I am aware that in the event of late payment of any amount due to IA Early Years GmbH, 5% (five-percent) interest per month will be charged from the due date until receipt of payment. However, if a late payment Payment

continues for more than one (1) month, IA Early Years GmbH may terminate the school contract at its own discretion and inform the Parent/Guardian of the disenrollment in writing. The provision regarding Early Departures applies correspondingly. Legal costs incurred by IA Early Years GmbH in the recovery of outstanding fees will be borne by the Parent/Guardian. Please note that the instalment payment also contains a surcharge. Credit card payment has a 3% surcharge on top of the chosen payment plan.

I understand that the stated fees are only for residents of Vienna, who are eligible for a childcare subsidy from the Municipal Department 10 (Basisförderung der MA10) by providing the MA10 Childcare No. (Kindergartennummer MA10).

If my child is still registered with another Kindergarten, does not have a Childcare No. or the number has not been given forwarded to the school, I agree to compensate for the monthly subsidy on top of the school fee plus an additional 13% V.A.T.
